# **HEALTH & SAFETY POLICY STATEMENT**

- Investigate accidents, incidents Good Catches and work-related ill health, identifying actions that can be taken to prevent recurrence.
- Audit the ISO 45001:2018 Health & Safety Management System for effectiveness throughout the organisation identifying and implementing improvements.
- Periodically review this policy ensuring to reflect the company's approach to Health & Safety with the workplace.
- This policy shall be made available to interested parties upon request.
- The Company sets objectives and targets which will be measured and reviewed at Management Review Meetings.

The company reminds employees that in Health & Safety matters they legally have individual and personal responsibilities and have a duty of care to take reasonable care and to co-operate with the company in complying with all statutory regulations, codes of practice and company rules relating to Health, Safety and welfare.
